

## TERMS AND CONDITIONS

1. The “Promoter” of the Coates Hire Ipswich SuperSprint, 20-22 July 2018 Competition (the “Competition”) is the Ipswich City Council (“the Promoter”).
2. Entry to the competition is open to people over the age of 18 years old. An entrant to the Competition must be an individual and not a company or organisation. Employees of the Promoter or any person associated with the Competition, or any organisation or individual associated with the provision of the prize(s) are not eligible to enter.
3. Each entry must be entered in accordance with these Terms and Conditions. By entering the Competition, each entrant agrees to be bound by these Terms and Conditions. The Promoter may at their discretion refuse to award any prize to any entrant who fails to comply with these Terms and Conditions.
4. Entries not made in accordance with these entry terms and conditions will be held invalid, and will not be considered. 6. Each individual entrant may only submit one (1) entry. All entries must be made online, through the Discover Ipswich electronic entry form .
7. By entering the Competition entrants agree to indemnify the Promoter against all loss, damage, costs (including legal costs) or liability whatsoever arising out of or in connection with the entrant’s breach of these terms and conditions.
8. Entrants must not engage in any unlawful conduct, or any misconduct which is calculated to jeopardise the fair and proper conduct, and the integrity of the Competition.
9. Only one winner will be chosen. The Promoter will choose the winner by way of a random draw. The result of the random draw is final and no correspondence and/or communication of any kind in relation to the result will be entered into. The Promoter is under no obligation to award a prize for the competition.
