

TERMS AND CONDITIONS

- 1.** The “Promoter” of the Century Batteries Ipswich SuperSprint 2019 Family Competition (the “Competition”) is the Ipswich City Council (“the Promoter”).
- 2.** Entry to the competition is open to people over the age of 18 years old. An entrant to the competition must be an individual and not a company or organisation. Employees of the promoter and their immediate family or any person associated with the competition, or any organisation or individual associated with the provision of the prize(s) are not eligible to enter.
- 3.** Each entry must be entered in accordance with these Terms and Conditions. By entering the Competition, each entrant agrees to be bound by these Terms and Conditions. The Promoter may at their discretion refuse to award any prize to any entrant who fails to comply with these Terms and Conditions.

- 6.** Any Information on how to enter the Competition forms part of these Terms and Conditions.
- 7.** Each individual entrant may only submit one (1) Competition entry. All entries must be made online, through the Discover Ipswich electronic entry form.
- 8.** By entering the Competition entrants agree to indemnify and release the Promoter in respect of any judgement, action, or liability for all loss, damage, injury (to persons or property), and costs (including legal costs) arising out of or in connection with the entrant’s participation in the Competition and/or breach of these terms and conditions.
- 9.** Entrants must not engage in any unlawful conduct, or any misconduct which is calculated to jeopardise the fair and proper conduct, and the integrity of the Competition.
