TERMS AND CONDITIONS

- 1.** The “Promoter” of the Ipswich Christmas Wonderland Bus Tour 5 x family passes Competition (the “Competition”) is the Ipswich City Council (“the Promoter”).
- 2.** Entry to the competition is open to people over the age of 18 years old. An entrant to the Competition must be an individual and not a company or organisation. Employees of the Promoter or any person associated with the Competition, or any organisation or individual associated with the provision of the prize(s) are not eligible to enter.
- 3.** Each entry must be entered in accordance with these Terms and Conditions. By entering the Competition, each entrant agrees to be bound by these Terms and Conditions. The Promoter may at their discretion refuse to award any prize to any entrant who fails to comply with these Terms and Conditions.
- 4.** Entries not made in accordance with these entry terms and conditions will be held invalid, and will not be considered. The Competition opens at 10.00 am on Friday 8th November 2019 and closes 10.00 am Friday 29th November 2019 (“Competition Period”).
- 5.** Any entry received after the closure of the Competition Period will be deemed invalid and will not be considered. No responsibility is accepted by the Promoter for late, lost, delayed or misdirected entries.
- 6.** Any Information on how to enter the Competition forms part of these Terms and Conditions.
- 7.** Each individual entrant may only submit one (1) Competition entry. All entries must be made online, through the Discover Ipswich electronic entry form.
- 8.** By entering the Competition entrants agree to indemnify and release the Promoter in respect of any judgement, action, or liability for all loss, damage, injury (to persons or property), and costs (including legal costs) arising out of or in connection with the entrant’s participation in the Competition and/or breach of these terms and conditions.
- 9.** Entrants must not engage in any unlawful conduct, or any misconduct which is calculated to jeopardise the fair and proper conduct, and the integrity of the Competition.
- 10.** Five winners for the grand prize will be chosen. The Promoter will choose the winner by way of a random draw at 11.00am on Friday 29th November 2019. The result of the random draw is final and no correspondence and/or communication of any kind in relation to the result will be entered into. The Promoter is under no obligation to award any prize for the competition.

11. Any prize awarded for winning the Competition is at the Promoter's discretion, and is non-negotiable, and may not be exchanged for cash or any other prizes.

12. Each of the 5 x Winners of the grand prize will receive:

a. 1 x Family Pass to attend the Ipswich Christmas Wonderland Bus Tour on a single night of their choosing. (Tours run each evening from 6pm to 9pm, Monday 16 December – Saturday 21 December 2019)

Family Pass includes guided commentary, a selection of the best displays from the 2019 Christmas Lights Competition, VIP Christmas Wonderland access at Nerima Gardens, supper, live entertainment, pick-up and drop off from the council car park on Roderick Street light supper and entertainment at the Visitor Information Centre.

b. Family (2A + 2C or 1A + 3C) Children (up to 12 years)

c. Total value for 1 x Family Pass = \$99. Total Value for the 5 x prizes = \$495

d. Prize does not include travel to and from the bus tour pickup and drop off point or accommodation.

13. Ipswich City Council is collecting your personal information for the purposes of conducting the Competition. We will not disclose your personal information outside of Council unless we are required to do so by law or you have given your consent.
